- Chair, Page Tompkins Edits made to Page's Proposal

MOTION – Page Tompkins made a motion that, while the PSB has reservations about the process for these latest changes; and fears unintended consequences and implementation challenges that may result from this level of reorganization done on this time table without broader consultation. We also have respect and deference for the staff who are tasked with managing these requirements and who have indicated that these changes will support a clearer and more efficient process. We continue to believe further reconsideration is needed and recommend that we send a revised version of our "Recommendation for Broader Reconsideration of the Qualifying Methods" to the State

- **MOTION** Page Tompkins made a motion to withdraw the recommendation for broader reconsideration of the qualifying methods. Irv Richards seconded. Motion passed with Kim Yarlott abstaining.
 - **2.** Ed 507.40 and 507.41 General Special Education Teacher and early Childhood Special Education Teacher Co-Chairs Cynthia Lucero and Joann Misra

There was discussion regarding combining some of the competencies as general competencies needed for both endorsements which has been done in the past. The subcommittee decided to leave them as is and not combine them.

- MOTION Cynthia Lucero made a motion to recommend to the State Board with new wording; General Special Education licensure shall qualify a teacher to teach children with disabilities who are able to benefit from General and Special Education but do not require the specialized knowledge and skills of an educator with a categorical endorsement as defined in Ed. 507.42, 507.43, 507.44, and 507.45 and whos placement is along the continuum of alternative education placements. Christie Sweeney seconded. Motion passed with Steve Appleby abstaining.
 - 3. Ed 507.11 and Ed 612.04 Elementary Education Teacher Co-Chairs Anne Wallace and Joanne Goezler

Joanne reported that the group met this month. They have made some progress and cleared up some of the grey areas. They hope to bring something to the board by February.
