Attached please find your New Hampshire Adequate Yearly Progress (AYP) report for Small Schools.

AYP decisions are made annually for public schools and districts in New Hampshire based on three factors: student performance (for student groups of 11 or more), participation rate (for student groups of 40 or more), and attendance rate for elementary/middle schools or graduation rate for high schools (for student groups of 40 or more).

Your school did not meet the minimum group size of 11 for student performance calculations to issue a yearly AYP report. This may happen for one of two reasons. Case 1: your school may in fact be very small (fewer than 11 students taught in grades 2-7 or 10). Case 2: your school may not have any students who participate in the fall assessment at the beginning of the next school year (e.g. a school that has grade 1 only). Note: schools that contain kindergarten only are not issued AYP reports because kindergarten attendance is offered, but not required, by the state.

The Department established a Small School Review process for schools that do not meet the minimum group size for reporting. In case 1, the process aggregates data over two, or three years if necessary, in order to meet minimum group sizes for reporting. In this case, AYP reports are based on 2, or 3, years of aggregated data. In case 2, the process reviews data generated by the school that next receives your students. In this case, your school inherits the AYP designation from the school that next receives the majority of your students. Your school falls within case 1. Your school made AYP.

Small Schools are schools with no group large enough to be evaluated within the normal accountability system. If the number is still less than 11, aggregate a third year of data and make the AYP determination. If the number is still less than 11, conduct a qualitative review to make the final AYP determination.

New Hampshire's approved accountability rule for making an AYP determination:

If the cell size is equal to or greater than 11 continuously enrolled students, calculate the index score for the group in Reading and in Math separately. The index score is the average of the index points in the group. Compare the group's index score in each content area to the state index targets to determine if the group has met: Condition 1) met or exceeded the index target; or Condition 2) scored within an acceptable range (Confidence Interval) of the index target for a group of its size; or Condition 3) has met the 10% rule.

New Hampshire's process for small schools once the minimum cell size is met:

Apply Condition 1 above, and Condition 2 if needed, to make the AYP determination. If the group's index score, when compared to the state index target, does not meet either Condition 1 or Condition 2, conduct a qualitative review to make the AYP determination.
