How this framework is organized

The material in the K-12 Mathematics Curriculum Framework is organized into Grade-Level Expectations (GLEs) and Grade-Span Expectations (GSEs). Both GLEs and GSEs contain statements about what ALL New Hampshire students are expected to know and be able to do. GLEs are standards that are delineated by grade level covering grades K-8. GSEs are standards that cover the high school span. Both the GLEs and GSEs are built upon the extensive work that went into the 1995 K-12 Mathematics Curriculum Framework and the earlier 1993 K-3 monograph.

Both the GLEs and GSEs are organized into four content strands (Number and Operations; Geometry and Measurement; Functions and Algebra; Data, Statistics, and Probability) and two process strands (Problem Solving, Reasoning, and Proof; Communication, Connections, and Representations).

At the beginning of each strand is a purpose statement which places the strand in the context of a K-12 mathematics program. Furthermore, each strand contains a number of big ideas referred to as stems. The stems articulate the main curricular focus and stay the same or similar across grades.

There are two types of standards throughout the document. Those identified for state assessment purposes and those identified for local curriculum and assessment. The state assessment standards appear in bold boxes; all other standards are guidance for local curriculum and assessment.

The organization of the GLEs and GSEs is further clarified in *About the Mathematics GLEs*, *Reading the Mathematics GLEs*, *About the Mathematics GSEs*, and *Reading the Mathematics GSEs*.

Rationale

In the early part of the 20th century, the needs of our society were dominated by an emerging industrial age driven by mass production. The needs of that society were served by mathematics education in which the acquisition of computational skills was the primary focus. Computational skills alone are no longer sufficient for the United States to remain competitive in the world marketplace. The economy is global, the economic environment is more competitive, the workforce is more mobile, and developments in technology are changing rapidly.

The level of mathematics needed for both intelligent citizenship and the workplace has increased dramatically. Although the acquisition of computational skills remains important, it is not sufficient. The definition of basics skills in mathematics must change to include mathematical problem solving, reasoning, the ability to communicate, and the use of appropriate technology in addition to being able to compute. Individuals need to be able to apply their understanding of mathematics to solve real-world problems for which there are no simple formulas and standard procedures. Individuals need to be able to use their knowledge of mathematics to make sense of complex situations and then communicate that understanding to others. Individuals need to be able to solve tomorrow's problems, as well as today's. Mathematics education in our schools must address these needs.

GOALS FOR MATHEMATICS EDUCATION

We commit to six primary goals. These goals are closely aligned with those espoused by various national commissions and groups in their efforts to reshape the teaching and learning of mathematics.

- All students will develop a firm grounding in number sense that includes computational fluency.
- All students will develop a basic understanding of key concepts and principles central to the study of geometry, algebra, probability, and data analysis, while appreciating the interrelationships of all areas of mathematics.
- All students will develop strong mathematical problem solving and reasoning abilities.
- All students will develop positive attitudes about mathematics.
- All students will develop the ability to use appropriate technology to solve mathematical problems.
- All students will develop the ability to communicate their understanding of mathematics effectively.

THE LEARNING ENVIRONMENT

The New Hampshire Mathematics Curriculum Framework provides a set of goals and standards for what ALL New Hampshire students are expected to know and be able to do. However, the “what” of the goals and standards needs to be considered in the context of the “how” of mathematics teaching and learning (i.e., what type of learning environments will foster students’ mathematical development consistent with the goals and standards). Every school-learning environment has several key components including the teachers, the learners, and the curriculum.

Knowledge needs to be well connected. Students who have memorized facts and procedures without understanding often do not know when or how to apply them. When students learn mathematics by doing mathematics, by exploring and discussing concepts in the context of physical situations, what emerges from these experiences are skills that are anchored in understanding and clarity. The students not only know the basic procedures, but also know how to apply them to new situations.

The attitudes students form influence their thinking and performance, and later, influence their decisions about studying mathematics. Students are active individuals who build new knowledge from experience and prior knowledge. The learning of mathematics must be an active process. The teacher plays a key role in establishing a learning environment where discussion and collaboration are expected and fostered, students are expected to justify their thinking, construct mathematical arguments, and experiment with various approaches. Beyond the physical environment, an attitude needs to be prevalent that all students can learn and that they will all be supported in efforts to attain this goal.

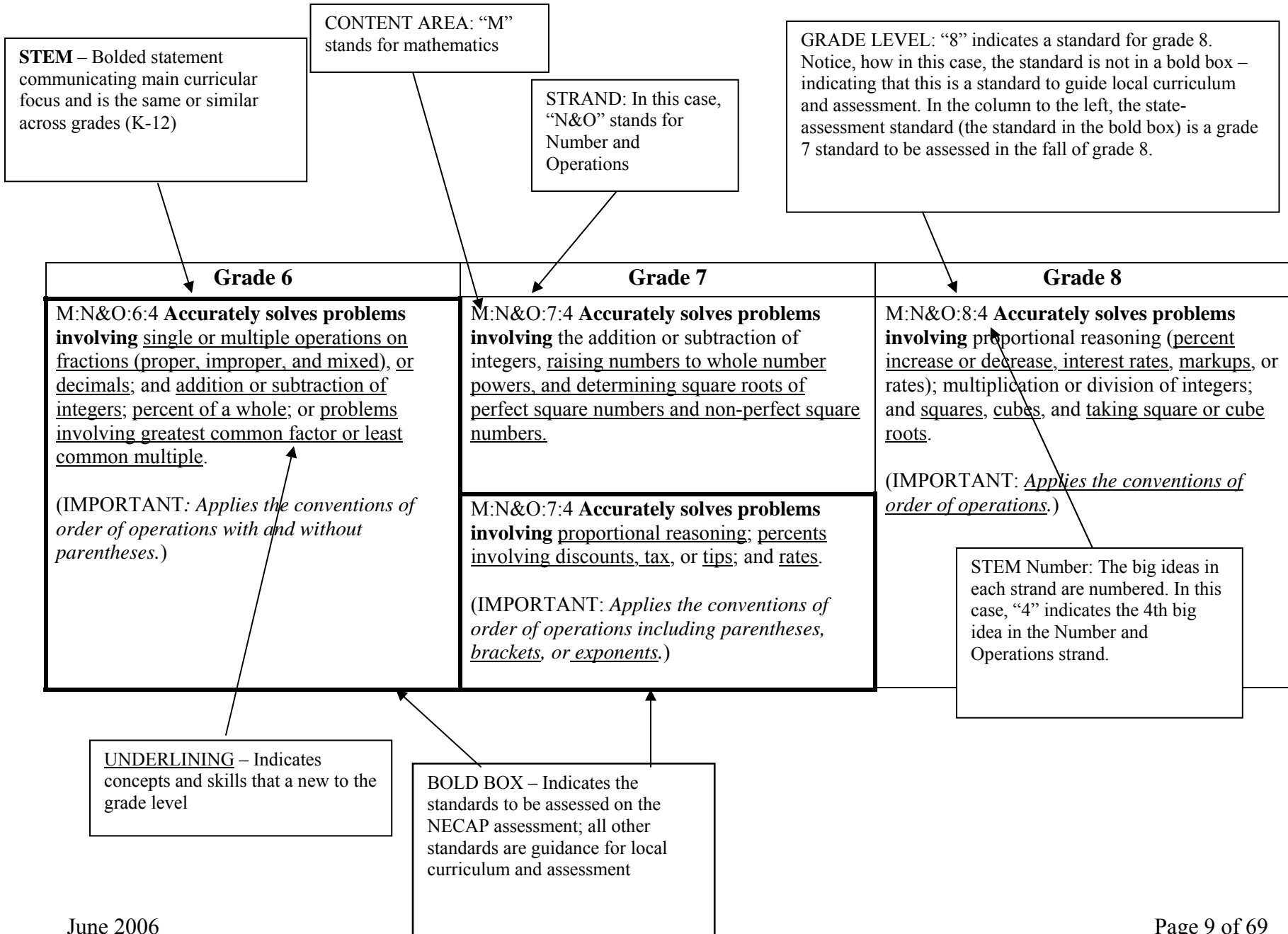
A learning environment that supports the stated goals for mathematics education has the following characteristics:

- students are actively involved in doing mathematics;
- problem solving, thinking, reasoning, and communicating are everyday activities;
- central mathematical concepts are understood;
- an appropriate balance between application and acquisition of knowledge and skills exists;
- manipulatives are used, when appropriate, to connect conceptual to procedural understanding;
- technology is used in appropriate ways;
- the curriculum is coherent and well-articulated across grade levels; and
- assessment is an integral part of instruction.

About the Mathematics GLEs

This set of New Hampshire Grade-Level Expectations (GLEs) for K-8 includes expectations that will be assessed on the state-level assessment and others that will be a local curriculum and assessment option (i.e., guidance for local curriculum and assessment but not assessed on the state assessment). Those GLEs that will be assessed on the state assessment are boxed with bold outlines. Furthermore, these assessment GLEs are common across NH, RI, and VT and will be assessed through the New England Common Assessment Program (NECAP). The assessment GLEs in this document can be interpreted as describing expectations for the end of the grade identified or the beginning of the next grade. The local content GLEs were developed in collaboration with the Rhode Island Department of Education. As you review the New Hampshire GLEs in Mathematics the following are important to understand.

- 1) The GLEs are organized into four content strands (Number and Operations; Functions and Algebra; Data, Statistics, and Probability; Geometry and Measurement) and two process strands (Problem-Solving, Reasoning, and Proof; Communications, Representations, and Connections).
- 2) Since it is crucial that process standards (problem-solving, reasoning, proof, communication, connections, and representations) are not seen separate from content standards, the process standards have been imbedded throughout the content strands (e.g., M:F&A:4:1 **Identifies and extends to specific cases a variety of patterns** (linear and nonlinear) represented in models, tables or sequences; and writes a rule in words or^{sc} symbols to find the next case.). This mirrors classroom instruction as in most classes, as students are learning content knowledge, instruction is also focusing on improving their abilities in problem solving, reasoning, and communication; furthermore, students are looking for and making appropriate connections, and they are able to understand and use multiple representations of mathematical ideas. Since it is crucial that students are strong in both content and process knowledge, we have included two local process strands following the content strands. These process strands are in addition to the process standards that are embedded in the content standards and are included to help guide local curriculum, assessment, and instruction. The process standards have been separated by grade-spans (K–2, 3–5, 6–8, and 9–12). The K–2, 3–5, and 6–8 spans have been included in this section of the document. Each span should be thought of as building upon the skills and concepts in the previous span.
- 3) Each GLE includes a **bolded** statement called the “stem.” Each “stem” is the same or similar across the grades for a given GLE, and is meant to communicate the main curricular and instructional focus of the GLE across the grades.
- 4) The unbolded text within a GLE indicates the expectations for that given grade-level.
- 5) The underlined text indicates the concepts and skills that are new to a given grade. (Note: Sometimes nothing is underlined within a GLE. In these situations, examine other GLEs across the strand to identify the differences or check the Depth of Knowledge table in the test specifications.
- 6) Each GLE is coded for the content strand, grade level, and the GLE “stem” number (e.g., M:F&A:7:3: The “M” stands for mathematics, the “F&A” stands for the Functions and Algebra strand, the “7” indicates a standard for grade 7 to be assessed in the fall of grade 8, and the “3” stands for stem 3 or the 3rd big idea in the Functions and Algebra strand). See the diagram on page 9.
- 7) Unless otherwise specified the number parameters defined in the Number and Operations strand for a particular grade-level apply to all GLEs at that grade-level.
- 8) All the concepts and skills identified at a given grade level that are boxed with bold outlines are “fair game” for state assessment purposes. However, conjunctions in this document have specific meaning. The conjunction “and” separates parts of a GLE that will be assessed every year (to the extent possible), while the conjunction “or” separates parts of the GLE that may be assessed each year, but will be more likely to be assessed over several years. In some situations “or^{sc}” is used. While students will have choices on strategies they use or methods to communicate their thinking throughout the assessment, there are special cases that the NECAP states thought it was necessary to communicate to the test developer that students should not be required to use a specific method (e.g., “...writes in words or^{sc} symbols...”).



Number and Operations

Purpose: Numbers and operations remain a cornerstone for the study of mathematics in grades K – 12. Students use numbers to quantify sets, identify location, measure, quantify the probability of an event, analyze data, and describe and interpret real-world phenomena. Having students know basic facts and having students compute fluently (i.e., accurately and efficiently) continues to be an important goal in mathematics education. However, knowing basic facts should be incorporated into a rich mathematics curriculum that builds conceptual understanding of these facts.

Through the school years, the amount of time spent on numbers and their operations will decrease and the types of numbers studied will change. As students progress through the elementary grades and into middle school, they will need to develop an in-depth conceptual understanding of fractions, decimals, and percents prior to doing algorithmic computations with these numbers. Conceptual development of integers and meaningful computation with them are also goals for middle grade students. The study of irrational numbers and the real number system will begin in eighth grade and continue through high school. Imaginary and complex numbers are introduced in advanced mathematics. It is important for students to model and represent the different types of numbers they study.

Students cannot appreciate the power of numbers unless they also understand the operations upon those numbers. Students need to recognize which operation to apply to a given problem situation they encounter. They need to know what effect the various operations will have on different types of numbers. They need to know the relationships among the operations and among the operations and their properties. A deep understanding of the operations and their properties will help students make sense of computation algorithms and lead to fluency in computation. A firm understanding of numbers as well as operations and their properties will provide a good foundation for the study of algebra.

Geometry and Measurement

Purpose: Geometry and the related area of measurement help students represent, describe, and make sense of the world in which they live. Geometry is also a natural place for students to develop their reasoning and justification skills.

We live in a three-dimensional world. To interpret, understand, and appreciate that world, students need to develop an understanding of space. In addition, success in mathematics depends, in part, on the development of spatial abilities. Spatial skills include making and interpreting drawings, forming mental images, and visualizing changes.

Measurement is the process of assigning a numerical value to an attribute of an object. The study of measurement provides students with techniques and tools they will need to describe and analyze their world. It also provides an opportunity to make connections within mathematics and between mathematics and other curricular areas. High school students must develop more mature insights into the essential role of measurement as a link between the abstractness of mathematics and the concreteness of the real-world.

In both areas, geometry and measurement, students need to investigate, experiment, and explore geometric properties using both technology and hands-on materials.

Since it is crucial that process standards (problem-solving, reasoning, proof, communication, connections, and representations) are not seen separate from content standards the process standards have been imbedded throughout the Number and Operations, Geometry and Measurement, Functions and Algebra, and Data, Statistics, and Probability strands (e.g., M:F&A:4:1 **Identifies and extends to specific cases a variety of patterns** (linear and nonlinear) represented in models, tables or sequences; and writes a rule in words or^{sc} symbols to find the next case.). This mirrors classroom instruction as in most classes, as students are learning content knowledge, instruction is also focusing on improving their abilities in problem solving, reasoning, and communication; furthermore, students are looking for and making appropriate connections, and they are able to understand and use multiple representations of mathematical ideas. Since it is crucial that students are strong in both content and process knowledge, we have included two local process strands. These process strands are in addition to the process standards that are embedded in the content standards and are included to help guide local curriculum, assessment, and instruction. The process standards have been separated by grade-spans (K–2, 3–5, 6–8, and 9–12). Each span should be thought of as building upon the skills and concepts in the previous span.

Problem Solving, Reasoning, and Proof

Communication, Connections, and Representations

Purpose: Reading, writing, talking, listening, and modeling provide students with the opportunity to develop deeper mathematical understanding and to integrate the language of mathematics into their world. Actively exploring, investigating, describing, and explaining mathematical ideas promote communication which leads to a greater comprehension of mathematical concepts.

Representing ideas and connecting the representations to mathematics lies at the heart of understanding mathematics. Representations make mathematical ideas more concrete and available for reflection, and they help students recognize the common mathematical nature of different situations. Students can develop and deepen their understanding of mathematical concepts and relationships as they create, compare, and use various representations.

Mathematical topics, ideas, and procedures must be connected to each other and to the students' everyday experiences, both in and out of school. In particular, mathematics must be connected to all other curriculum areas. Mathematical connections will help students become aware of the usefulness of mathematics, serve to bridge the concrete and the abstract, and enable deeper understanding of important ideas.

Appendix A: M:N&O:2.3

M:N&O:2.3 Demonstrates conceptual understanding of mathematical operations involving addition and subtraction of whole numbers by solving problems involving joining actions, separating actions, part-part whole relationships, and comparison situations. (See Appendix A.)

Classification of word problems: Researchers have identified four basic categories of addition and subtraction problems: problems with joining actions, separating actions, part-part whole relationships, and comparison situations. Table 1 contains some examples to illustrate the distinctions in the categories identified by the researchers, but there may be additional ways to express the same actions, relationships, or situations. For example, the following are additional ways to ask questions related to the “Join – Start Unknown” category.

Example 1: “I am thinking of a number that when you add 5 to it, the answer is 13. What number am I thinking of?”

Example 2: John puts a five-pound toy inside an empty wooden box. The box and toy together weigh 7 pounds. How much does the empty box weigh?

In summary, students should have experiences with problem solving in addition and subtraction across a variety of problem types. It is important to remember that any problem situation that fits the equations given and the category can be asked, not just problems as stated in Table 1.

“Teaching students to add and subtract involves providing students with an opportunity to explore a rich set of problems with different semantic structures and to develop a variety of strategies to quantify, represent, calculate, express, and justify results.” (Gutstein, E., Romberg, 1995)

Appendix B: Measurement Benchmarks

The following is a list of the measurement benchmarks and equivalences that *can be used* in problems across the content strands at each grade level to address the expectations in M:G&M:X:7 for the New England Common Assessment Program².

M:G&M:X:7 Uses units of measures appropriately and consistently, and makes conversions within systems when solving problems across the content strands.

The type of measure (e.g., length, time, etc.), the unit (e.g., inches, feet, etc.), the degree of accuracy where appropriate (e.g., ½ inch); and equivalences (e.g., 12 inches in a foot) are identified for grades 2 – 8. In addition to measurement benchmarks identified below students will be expected to use the appropriate units when solving problems involving area, volume, surface area, conversions, and rates (e.g., miles per hour, price per pound, pounds per square inch) on the NECAP Assessment.

About the Mathematics GSEs

This set of New Hampshire Grade-Span Expectations (GSEs) for high school includes expectations that will be assessed on the state-level assessment and others that will be a local curriculum and assessment option (i.e., guidance for local curriculum and assessment but not assessed on the state assessment). Those GSEs that will be assessed on the state assessment are boxed with bold outlines. Furthermore, these assessment GSEs are common across NH, RI, and VT and will be assessed through the New England Common Assessment Program (NECAP). **The assessment GSEs in this document can be interpreted as describing expectations for the end of grade 10, or the beginning of grade 11.** The local content GSEs were developed in collaboration with the Rhode Island Department of Education. As you review the New Hampshire GSEs in Mathematics the following are important to understand.

- 1) The grade 8 Grade-Level Expectations (GLEs) are included in this document in order to see how the concepts and skills develop from grade 8 to high school.
- 2) The GSEs and GLEs are organized into four content strands (Number and Operations; Functions and Algebra; Data, Statistics, and Probability; Geometry and Measurement) and two process strands (Problem-Solving, Reasoning, and Proof; Communications, Representations, and Connections).
- 3) Since it is crucial that process standards (problem-solving, reasoning, proof, communication, connections, and representations) are not seen as completely separate from content standards, the process standards have been imbedded throughout the content strands (e.g., M:F&A:10:1 **Identifies, extends, and generalizes a variety of patterns** (linear and nonlinear) represented by models, tables, sequences, or graphs in problem solving situations). This mirrors classroom instruction in most classes. As students are learning content knowledge, instruction is focusing on improving their abilities in problem solving, reasoning, and communication. Students should be looking for and making appropriate connections, and should be able to understand and use multiple representations of mathematical ideas. Since it is crucial that students are strong in both content and process knowledge, we have included two local process strands following the content strands. These process strands are in addition to the process standards that are embedded in the content standards and are included to help guide local curriculum, assessment, and instruction. The process standards have been separated by grade-spans (K–2, 3–5, 6–8, and 9–12). The 6–8 and 9–12 spans have been included in this section of the document. Each grade span should be thought of as building upon the skills and concepts in the previous grade span.
- 4) Each GSE and GLE includes a **bolded** statement called the “stem” which is the same or similar across the grades for a given GSE or GLE. Each stem is meant to communicate the main curricular and instructional focus of the GSE or GLE across the grades.
- 5) The unbolded text within a GSE or GLE indicates the expectations for that given grade-level or grade-span.
- 6) The underlined text at grade 8 indicates the concepts and skills that are new to grade 8 from grade 7. (Note: Sometimes nothing is underlined within a GLE. In these situations examine other GLEs across the strand to identify the differences or check the Depth of Knowledge table in the test specifications.)
- 7) Each GSE is coded for the content strand, grade level, and the GSE “stem” number (e.g., M:F&A:X:3 where X = 10, HS, or AM: The “M” stands for mathematics, the “F&A” stands for the Functions and Algebra strand, the “10” indicates that the standard is a state assessment standard for the end of grade 10 or beginning of grade 11, “HS” indicates a local high school expectation for all students, an “AM” indicates a local expectation for students preparing for advanced mathematics courses (e.g., calculus), and the “3” stands for stem 3 or the 3rd big idea in the Functions and Algebra strand). See the diagram on page 45.
- 8) Unless otherwise specified the number parameters defined in the Number and Operations strand for a particular grade-level or grade-span apply to all GLEs at that grade-level or all GSEs at that grade-span.
- 9) All the concepts and skills identified in the assessment GSEs are fair game for assessment purposes. However, while all parts of a GSE may be assessed each year, it is more likely that all parts of a GSE will be assessed over several years.
- 10) In some places you will see “or^{sc}” (“sc” stands for “student choice”). While, in general, students have choices as to the strategies that they use to solve problems, “or^{sc}” was used to explicitly state to the testing contractor that a particular strategy could not be required. For example, as in GSE M:DSP:10:4: “...using a variety of strategies (e.g., organized lists, tables, tree diagrams, models, Fundamental Counting Principle, or^{sc} others).”
- 11) While the use of dynamic software will not be assessed on the state-level assessment at this time, it is expected that students at the high school level would receive ample opportunity to solve problems using dynamic software at the local level.

Number and Operations		
<p>Purpose: Numbers and operations remain a cornerstone for the study of mathematics in grades K – 12. Students use numbers to quantify sets, identify location, measure, quantify the probability of an event, analyze data, and describe and interpret real-world phenomena. Having students know basic facts and having students compute fluently (i.e., accurately and efficiently) continues to be an important goal in mathematics education. However, knowing basic facts should be incorporated into a rich mathematics curriculum that builds conceptual understanding of these facts.</p> <p>Through the school years, the amount of time spent on numbers and their operations will decrease and the types of numbers studied will change. As students progress through the elementary grades and into middle school, they will need to develop an in-depth conceptual understanding of fractions, decimals, and percents prior to doing algorithmic computations with these numbers. Conceptual development of integers and meaningful computation with them are also goals for middle grade students. The study of irrational numbers and the real number system will begin in eighth grade and continue through high school. Imaginary and complex numbers are introduced in advanced mathematics. It is important for students to model and represent the different types of numbers they study.</p> <p>Students cannot appreciate the power of numbers unless they also understand the operations upon those numbers. Students need to recognize which operation(s) to apply to a given problem situation they encounter. They need to know what effect the various operations will have on different types of numbers. Geometry and Measurement

Purpose: Geometry and the related area of measurement help students represent, describe, and make sense of the world in which they live. Geometry is also a natural place for students to develop their reasoning and justification skills.

We live in a three-dimensional world. To interpret, understand, and appreciate that world, students need to develop an understanding of space. In addition, success in mathematics depends, in part, on the development of spatial abilities. Spatial skills include making and interpreting drawings, forming mental images, and visualizing changes.

Measurement is the process of assigning a numerical value to an attribute of an object. The study of measurement provides students with techniques and tools they will need to describe and analyze their world. It also provides an opportunity to make connections within mathematics and between mathematics and other curricular areas. High school students must develop more mature insights into the essential role of measurement as a link between the abstractness of mathematics and the concreteness of the real-world.

In both areas, geometry and measurement, students need to investigate, experiment, and explore geometric properties using both technology and hands-on materials.

Since it is crucial that process standards (problem-solving, reasoning, proof, communication, connections, and representations) are not seen as completely separate from content standards, the process standards have been imbedded throughout the content strands (e.g., M:F&A:10:1 **Identifies, extends, and generalizes a variety of patterns** (linear and nonlinear) represented by models, tables, sequences, or graphs in problem solving situations). This mirrors classroom instruction in most classes. As students are learning content knowledge, instruction is focusing on improving their abilities in problem solving, reasoning, and communication. Students should be looking for and making appropriate connections, and should be able to understand and use multiple representations of mathematical ideas. Since it is crucial that students are strong in both content and process knowledge, we have included two local process strands following the content strands. These process strands are in addition to the process standards that are embedded in the content standards and are included to help guide local curriculum, assessment, and instruction. The process standards have been separated by grade-spans (K–2, 3–5, 6–8, and 9–12). The 6–8 and 9–12 spans have been included in this section. Each grade span should be thought of as building upon the skills and concepts in the previous grade span.

Problem Solving, Reasoning, and Proof	
<p>Purpose: Problem solving should serve as the organizing feature of the mathematics curriculum (as well as other areas of study) and be applied to everyday activities. Thus, problem solving approaches should be used to investigate and understand new mathematical content, with students working sometimes independently and sometimes in groups. Communication, Connections, and Representations
