By signing below, the superintendent and principal hereby assure the New Hampshire Department of Education (NH DOE) and the United States Department of Education (US ED) that \_\_\_\_\_ school will:

- Assemble a leadership team to prepare and implement an approved school improvement plan using the Indistar tool during the 2013-14 school year.
- Use the *Steps to Success* self-assessment process to examine current practices and develop plans for implementing strategies aligned to the seven turnaround principles. These principles include: 1) providing strong leadership; 2) improving instruction through effective teaching; 3) redesigning the school to include additional time; 4) strengthening the school's instructional program; 5) using data to inform instruction; 6) improving the school environment including school safety and discipline; and 7) providing family and community engagement.
- Administer the programs, activities and services covered within the school improvement plan in accordance with all applicable federal and state regulations and laws.
- Ensure an intervention, or interventions are included in the School improvement plan to meet the expectations of Principle 5. (*Please see Principle 5 of the Turnaround Principles.*)
- Design and implement interventions consistent with Title I, Part A and Title I, Part A 1003(a) allowable uses.
- Use the school's Title I, Part A 1003(a) funds, as well as the district's Title I, Part A 10 percent set-aside to supplement, not supplant federal, state and local funds that the school would otherwise receive.
- Participate in the New Hampshire Networks that are aligned to the turnaround principles and the school's improvement plan as determined by the school's *Steps to Success* self-assessment (e.g. Educator Effectiveness, Principal Leadership, Data Collection and Use, RtI-MTSS (Response to Instruction-Multi-tiered System of Support, College and Career Ready Standards; Increased Time and Culture and Climate).
- Submit to the NH DOE requested reports that document the progress of activities approved in the school's improvement plan and addresses current student achievement data.
- Submit specific school-level data and/or fiscal information required by the NH DOE.
- Conduct recruitment, screening and selection of external providers, if applicable, in a manner that documents and ensures a high level of quality service.
- Sustain the effective interventions after the improvement funding period ends.
- Implement a Leader and Educator Evaluation and Support System(s) containing the guidelines in the state models and basing 20 percent of the evaluation results on student growth.
- Modify district practices and/or policies, if necessary, to enable the school to implement the approved interventions fully and effectively.
- Assures that the school principal has a track record in improving achievement and has the ability to lead the turnaround effort. (*Please see Principle 1 of the Turnaround Principles attached*)
