Re: SPP/APR Timeliness of Early Transitions 2014-2015

Indicator 12: Percent of children referred by Part C (FCESS) prior to age 3, who are found eligible for Part B (Preschool special education), and who have an IEP developed and implemented by their third birthday.

The New Hampshire Department of Education, Bureau of Special Education, is developing the FFY 2014 State Performance Plan (SPP) for Indicator 12: Early Transitions from Part C Family-Centered Early Supports & Services (FCESS) to Part B Special Education. **This year, the NHDOE is generating a report from NHSEIS based on the children whose data transferred from NH Leads to NHSEIS.** To be proactive, districts should go into NHSEIS and review all transitions to ensure data are complete and accurate. For any children that have valid parent delays, begin to prepare your evidence to provide to the NHDOE.

In May of 2015, the NHDOE will review the NHSEIS report to determine any potential noncompliance. Districts that are flagged with potential noncompliance will be notified by the NH Department of Education and offered an opportunity to provide information regarding valid parent delays or to provide additional explanations regarding the data prior to the end of June 2015. Districts that are determined to be in compliance will not need to take any action.

For purposes of this desk audit, the State will be reviewing data on children who were referred from FCESS to your district with a date-of-birth from July 1, 2011 through October 31, 2011, inclusive. This data will be used to generate State and district compliance with Indicator 12. The data will be used in the calculation for District Data Profiles and will be used as a factor in the determination of a district's implementation of IDEA.
