INDICATOR 4A: The State reported its definition of “significant discrepancy”.

The State reported that no districts were identified as having a significant discrepancy in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that the State-established minimum “n” size requirement is 11 students with IEPs in the district and four students with IEPs suspended or expelled for greater than ten days. Because the State determines whether there are any districts with a significant discrepancy (and there none) before it applies the “n” size, the State did not report the number of districts excluded from the calculation based on the “n” size.

The State reported that no districts were identified as having significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that seven of 174 districts did not meet the minimum “n” size requirement of more than 11 students with IEPs in the identified racial or ethnic group(s) and at least four students with IEPs suspended or expelled for greater than 10 days.

INDICATOR 9: The State reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services.

The State reported that 160 of 174 districts did not meet the State-established minimum “n” size requirement of at least 40 students enrolled in two or more racial/ethnic subgroups and within those subgroups, at least ten students were identified as receiving special education and related services.
