

Summary of New COVID - 19 Waivers for NH SAUs

Period Covered By This Information: Up to June 30, 2020

Below is a summary of NEW nationwide and state waivers of Child Nutrition Program regulations that are in effect while schools buildings are closed, but remote learning is happening. The below new waivers are in effect until June 30, 2020.

- **Parent Pick-Up Waiver for the Fresh Fruit and Vegetable Program** Allows the parent/guardian to pick up their child's fresh fruit or vegetable item.
- Local School Wellness Policy Triennial Assessment Waiver This waiver extends deadlines for the Triennial Assessment requirement.
- Food Service Management Company Waiver Allows SAUs with a food service management company contract that is in its final year to extend the contract by one additional year before having to rebid.
- Extension of Unanticipated School Closure to June 30, 2020 Waiver – SAUs are able to serve meals as they are now up to June 30, 2020. This allows a smoother transition to a summer program.

Can we serve meals during the summer of 2020 the same way we are now?

Update: The waiver submitted by the NH DOE Office of Nutrition Programs and Services is currently at the highest level. We hope to hear soon regarding approval for non-congregate feeding and any other waiver submitted.
