# (a) A brief statement explaining how the program is meeting the goals of its mission statement

The NHAS Learn Everywhere (LE) program has specific goals that each student must complete in their summer program. The NHAS LE had 7 students in the LE this first year. As our rubric and curriculum detail, these included the students' written research proposals, their execution of the bench research, the gathering of results including any relevant statistical analyses and graphical representation. These lead to the students presenting their research in final research papers and presenting their work in abstracts and poster presentations. All of the students in the LE program who began, finished and all received a certificate of completion. All LE students also went onto presenting their work at a national conference of the American Association for the Advancement of Science (AAAS) and all published their posters on the "Project Board". Finally, all LE students published their research in abstract format with the AAAS. We believe this completely fulfils the goals and objectives that were the basis upon which we received LE approval by the NH Department of Education.

(b) The number of students enrolled in the program and the number of students awarded certificates leading to high school credits for the previous school year.

In the 2020/2021 New Hampshire Academy of Science had Seven (7) students enroll in and earn Learn Everywhere credit.

To the NH State Board of Education,

Portsmouth Aikido is a 501(c)3 educational non-profit organization dedicated to practicing and teaching the traditional Japanese martial art of Aikido. Our goal is to provide top notch instruction and a positive community for kids and adults to learn Aikido.

We have been in continuous operation since 1995, and despite the many challenges posed by the pandemic we have maintained our practice throughout and currently offer classes seven days a week with approximately 75 students at the dojo.

We currently have one student participating in LENH, a sophomore at Portsmouth High school. He is scheduled to earn his first ½ credit in the fall. He is our first LENH participant.

Overall, we are happy to offer the opportunity for young people to earn academic credits, and we have a <u>full page on our website</u> to help promote the program. We have yet to find much interest in the program on our own, and we would appreciate whatever help the state could provide to spread the word. If other organizations have found success in this regard, we would appreciate hearing more about what they've done.

Our biggest challenge thus far has been coordinating with the cooperating school. When our current student first expressed interest in earning academic credits throughout our LENH program, I reached out to his guidance counselor at PHS. She was unaware of the program and told me he would not be able to earn credits because I/we had not gotten prior approval.



This letter serves as the 2021/22 annual report for the FIRST NH Learn Everywhere (LE) program. In this initial year for the FIRST NH LE program, the focus has been on creating awareness within our high school level FIRST teams that students can now earn course credit for the skills and competencies that they have developed through their participation in FIRST. For many of our students, the LE program allows them to earn credit in subject areas that are not normally available to them through the standard curriculum, and the LE program recognizes that the skills they acquire through FIRST form a meaningful part of their education and career development.

For the 2021/22 school year, FIRST NH had one student complete the LE program and this student received 3½ credits across 4 subject areas:

- Business Technology (1 credit)
- Marketing (½ credit)
- Business Education (1 credit)
- Computer Science (1 credit)

The FIRST NH LE program is a new opportunity for our students, mentors and schools, and it has taken some time for everyone to become familiar with the LE program, the course offerings, and the process to be followed in order to earn those credits. While we have had considerable interest in the LE program among our FIRST teams, we had only that one student complete the requirements and receive course credits. However, we are encouraged by the interest that all have shown in the LE program and we look forward to a significant increase in the program participation in the coming school year. On behalf of all our NH FIRST students, we thank the NH Department of Education for this unique opportunity that the LE program represents.

To Whom It May Concern:

- (a) A brief statement explaining how the program is meeting the goals of its mission statement. The Learn Everywhere program is designed to give families the resources and autonomy to choose what educational paths are right for their high school students. The program allows students earn certificates for high school credits through the same organizations they are utilizing for other activities and services, such as tutoring. Sylvan Learning has provided supplemental educational support to students in New Hampshire for over 20 years. Through the Sylvan for Credit program for the Learn Everywhere, New Hampshire high school students can receive credit for academic courses completed outside of the public school. Each Learn Everywhere Sylvan for Credit student is assigned a course teacher to grade items, track progress, and respond to student questions, a Student Success Coach to monitor the student's progress and notify the Sylvan management and instructional team of issues, and a Sylvan Academic Coach to provide course content support as appropriate and explicit instruction in study skills such as time management, goal setting, note-taking, and test preparation.
