The New Hampshire Department of Education (NHED), Bureau of Special Education Support (Bureau) is writing to report the results of the NHED Special Education Program Approval Review of the **SUNSS (Students Under Six Needing Specialized Services) at Clark-Wilkins Elementary School** for students with educational disabilities as required by RSA 186:C. The criteria for the program approval review are specified in the <u>New Hampshire Standards for the Education of Children with Disabilities</u>, effective May 24, 2017, Amended June 14, 2019, Amended August 9, 2018, Amended April 10, 2020 and IDEA 2004.

The New Hampshire Department of Education has approved your request to **add the disability** area of Developmental Delay for SUNSS (Students Under Six Needing Specialized Services) at Clark-Wilkins Elementary School effective September 27, 2022.
