The New Hampshire Department of Education (NHED), Bureau of Special Education Support (Bureau) is writing to report the results of the NHED Special Education Program Approval Review of the **Concord Developmental Preschool** at **Abbott-Downing School** for students with educational disabilities as required by RSA 186:C.
