## 2 Right Question Institutes (RQI) Question Formulation Technique (QFT)

The work session commenced with an interactive presentation by Maureen Callaghan, who introduced the Question Formulation Technique (QFT) and the Right Question Institutes (RQI). Despite encountering quorum challenges, members actively participated in the session, focusing on formulating questions pertinent to the committee's focus statement: "We need a new higher education system to anticipate the needs of students with disabilities."

Maureen's facilitation enabled committee members to engage in fruitful brainstorming, emphasizing the importance of questioning in problem-solving. The session generated valuable questions and insights to guide future discussions and actions related to higher education accessibility for students with disabilities.

Following the interactive session, the committee attempted to provide public comments for the NH Public Higher Education Task Force meeting. However, due to quorum constraints, a consensus for public comments could not be reached.
