Questions and Answers

- 1. Whether companies from Outside USA can apply for this?
(like, from India or Canada)**
Yes, we accept proposals from out of the United States but require data to be stored in the United States. See Addendum #1.
- 2. Whether we need to come over there for meetings?**
No, virtual meetings are acceptable.
- 3. Can we perform the tasks (related to RFP) outside USA? (like, from India or Canada)**
Yes, but require data to be stored in the United States. See Addendum #1.
- 4. Can we submit the proposals via email?**
Yes, proposals are required to be submitted via email to the RFP designated point of contact.
- 5. Is the Appendix B in the desired end format? Should Appendix B be submitted as an excel document?**
Appendix B can be submitted as an Excel Document or fully included in the PDF submission.
- 6. Is it permissible to include appendix items to supplement our responses in sections 1-5?**
No it is not permissible.
- 7. If appendix items are permitted, is there a desired end format (e.g., separate file that is clearly named, embedded file, linked to a website or web-based resource)? e.g Pricing Appendix**
Submit as an attachment clearly marked - PDF form.
- 8. What NH data is this after school data management solution expected to connect to in near real time?**
The New Hampshire Department Education data.
- 9. Are you seeking pricing per center/site per year? Or a 5 year total? Is there a pricing format or for you would like us to use?**
We are seeking pricing for a 5 year total, the contract will be written with a 'will not exceed amount'. Although, amendments for funding may be allowed yearly.
- 10. How many 21st CCLC centers are being funded now? What is your projection for number of centers over the next 5 years that will be part of this project?**
31 Grantees and 64 sites are currently being funded. There is no way to project the number of centers to be funded over the next 5 years.
