



ACCESS for ELLs Scoring Appeal Request Information 2022–2023

Scoring Appeals are most often requested by the state education agency (SEA), local education agency (LEA), or school. The Scoring Appeal Process should be utilized when there is a concern that a student's test may have been scored incorrectly.

Scoring Appeals are only for students' responses on the Writing and Speaking tests and are not applicable to multiple-choice items. Therefore, only grades 1–12 Speaking (Online) and Writing (Online and Paper) tests will be available for rescoring. Kindergarten and Alternate tests are entirely multiple-choice and are, therefore, not applicable, to the Scoring Appeal Process.

Scoring Appeal Process

The SEA completes, signs, and posts to the DRC SFTP site, faxes, or mails the **Scoring Appeal Request Form** to DRC.

If the student's score <u>does</u> change, a new State Student Response File, District Student Response File (affected records only), and an Individual Student Report (affected students only) will be generated and posted on WIDA AMS. No other reports will be generated.

If the student's score does not change, the site will be notified and no reports or data files will be generated. A \$200 fee per domain will be incurred for each student needing a Scoring Appeal.

DRC will have three Scoring Appeal processing windows:

- The first window will be for all Scoring Appeals received at DRC by June 22, 2023. If the Scoring Appeal results in a better score, the posting of the online reports will be August 1, 2023.
- The second window will be for all Scoring Appeals received at DRC by August 3, 2023. If the Score Appeal results in a better score, the posting of the online reports will be September 12, 2023.
- The third window will be for all Scoring Appeals received at DRC by September 18, 2023. If the Score Appeal results in a better score, the posting of the online reports will be October 27, 2023.
