Issued February 3, 2023

1. Section 1.1 Overview, correct the start date of the contract by replacing the first sentence with:
 - The Department of Education, Bureau of Adult Education, is seeking proposals to provide adult education services under the Workforce Innovation and Opportunity Act (WIOA) of 2014, for the period from July 1, 2023 until June 30, 2026.
2. Section 2.2, Bureau of Adult Education, add “Integrated Education & Training” to the last sentence:
 - A separate competition will be conducted for Integrated Education & Training and for Integrated English Literacy and Civics Education programs.
3. Section 3.3.4, definition of low-income is revised to read:

In General – The term “low-income individual” means an individual who-

 - i. receives, or in the last 6 months has received, or is a member of a family that is receiving or in the past 6 months has received, assistance through the supplemental nutrition assistance program established under the Food and Nutrition Act of 2008 (7 U.S.C. 2011 et seq.), the program of block grants to States for temporary assistance for needy families program under Part A of title IV of the Social Security Act (42 U.S.C. 601 et seq.) or the supplemental security income program established under title XVI of the Social Security Act 42 U.S.C. 1381 et seq.), or State or local income-based public assistance;
 - ii. is in a family with total family income that does not exceed the higher of-
4. Replace Section 4.2, first three paragraphs with:
 - Proposals submitted in response to this RFP must be received by the Bureau of Adult Education, no later than the time and date specified in the Schedule section, herein. Proposals may be submitted electronically or by either U.S. Mail or In Person.

10. Replace Attachment 2A with Attachment 2A AEL for Corrections Application V2. The only change is to allow for Text Wrap on the Organizational Capacity Worksheet for the Titles, Qualifications and Responsibilities section.
