

Bedford's Plan on the Safe Return to In-Person Instruction & Continuity of Services Links for Mitigation Measures Updated for 8.16.21 School Board Meeting

Context

On July 27, 2020 the Bedford School Board approved the <u>Reopening Plan</u> for the 2020-2021 school year. Additionally, the board approved <u>Reopening Metrics</u> to assist the school administration in utilizing data and evidence-based practices to determine the phases of reopening. Weekly meetings were held with the Metrics Team. At the end of each meeting, the community was updated through Bedford's <u>Metrics website</u>. Email communications were also sent home via Superintendent updates and individual school Principal's Notes.

Note: Approximately 15% of the total student population requested Bedford's fully remote option.

Key Dates

August 27, 2020 - All Bedford Schools opened utilizing a hybrid model with a remote option. February 8, 2021 - K & 1st grade hybrid students returned in-person full time, 5 days per week.

February 12, 2021 - Grades 2-8 hybrid students increased from 50% to 60% in-person learning. March 8, 2021 - Grade 2-8 hybrid students returned in person full time, 5 days per week. March 29, 2021 - Grades 9-12 hybrid students returned in-person full time, 5 days per week.

Substantive Changes from 2020-2021 Reopening Plan to 2021-2022

- Masks are recommended but not required for students ages 11 and under. Staff and students may elect to wear masks, but are not required to do so.
- In grades 7-12, the Bedford School District will return to pre-covid operations as the vaccine is widely available for all persons ages 12 and older.
- Remote Learning will only be available to students as a result of an Individual Education Plan (IEP) or as a result of reasonable accommodations through a Section 504 Plan. These are team decisions.
- Concurrent Learning (e.g., Zoom in the Room) will not be offered. Exceptions for concurrent learning will be the same as those for remote learning as stated above.
- In grades PreK-6, the Bedford School District will work within the guidelines of the CDC, DHHS, and NHDOE.
- With Bedford schools at full capacity, physical distancing will not be possible.
- Parent Volunteers will be permitted per School Board Policy **JJOC**.

I. Transparency & Accessibility

 The Bedford School District utilized a <u>Reopening Task Force</u> to make recommendations to the Superintendent and School Board regarding the Reopening Plan for the 2020/21 school year. The final plan was posted on each school website after being approved by the school board.

- 2. Public comment on the plan was made through the Task Force and at summer board meetings, which were held in the BHS Theater prior to approval.

V. Plan Review
