The technologization of the workplace and pace of skills change are creating new urgency for lifelong learning

- 9.6 million job openings still near record high
- 3.0% unemployment rate for workers with some college or associate degree
- 4 in 5 em ployers globally (77%) reporting talent shortages – a 17 year high
- Mobile, cloud computing, analytics, AI, automation driving upskilling needs across industries
- 40% of core skills expected to change over next 5 years → 50% of employees requiring upskilling of 6 months or less




The market for non -degree credentials is booming



- 1 million credentials are available in the U.S.
 - 660,000 from non-academic providers
 - 350,000 degrees and certificates
- 74 million digital badges issued in 2022 –
 73% growth from 2020, and tripling since 2018
- Short-form offerings have emerged as a top educational format preference for working professionals and adult learners
- Publicly traded online education provider results (e.g., Coursera and 2U) suggest 10-20% annual growth rate





- Modular courses no bigger than 3 credits
 - Reviewing 8 week versus full semester models


- Integrated communication skills and workforce ready depositions





The Annie E. Casey Kids Count Data Center reporting of race and ethnicity indicates that the NH population under 18 are more diverse than the state overall. The Kids Count Data Center provides age specific estimates, which show that children under 18 range from 16-18% BIPOC and/or Hispanic (using US Census Bureau estimates from 2016-2020).













Students Educated by CCSNH Fall 2020 – Fall 2023



CCSNH Dual Enrollment Students AY19 – AY23







Matriculation Among Dual Enrolled Students 2016-2023


