**NH DOE policies and procedures updates -** Rebecca updated the committee on the rules for inclusive of 21 years of age. Currently the DOE is unable to find someone to fill the position of the office of the special ed advocate

Due Process, Mediation, and State Complaints - Rebecca stated she has not been able to do this yet

Joe Costanzo explained the difference between the Department of corrections and County of corrections

**Correspondence with Melissa White -** Discussion on letter written to Ms. White on behalf of the committee. As of today, the DOE has given SAC access to be able to have remote meetings but the concern is maintaining the zoom account, Right To Know requests, and RSA 91:a implications. The SAC committee does not have funds for legal counsel if needed.
