- Congratulations to Dr. Randy Wormald of SAU #46 who has been named the 2022 **Outstanding Service Award Winner** by the New Hampshire School Administrators Association.
- The NH Department of Energy will be rolling out a Notice of Funding Availability next month seeking applications for its **School Energy Efficiency Development (SEED)** grant program. One grant in the amount of \$100,000 will be awarded with a 10% match requirement. This program provides support and technical assistance for a school in a small community to implement energy efficiency projects and make necessary upgrades. The SEED grant program will likely open in mid-May. A formal NOFA will be posted [here](#).
- NHED's Bureau of Adult Education has issued a [request for applications](#) for the provision of **summer programming** for Adult Diploma Programs and Adult Education Literacy Programs. Applications are now available and will be reviewed on a rolling basis. A total of \$700,000 is available, with the purpose of targeting federal and state adult education funds to eligible ADP and AEL programs in support of year-round programming, including access to adult education services over the summer.
- NHED is pleased to announce the selection of Concord School District and SAU #7 as inaugural members of the **Innovation Schools Fellowship**. - On Wednesday, the Governor and Executive Council unanimously appointed **Melissa White** as the new director of NHED's Division of Learner Support. We are excited to welcome Melissa into this new leadership position.

- NHED is wrapping up its **iPlatform training** sessions with specialized webinars for [school counselors](#) at 3:15 p.m. on May 3 and for [English Language educators](#) at 3:15 p.m. on May 5. [Registration](#) is now open.

- The NH Department of Health and Human Services currently has over-the-counter, **COVID Rapid Antigen test kits** available for schools and daycares. The tests are packaged individually with instructions, and do not require any special licensing requirements. For schools to access test kits, they should complete this [form](#). Tests may be picked up from 8:30 a.m. to 3:30 p.m. Monday-Friday at the warehouse at 23 Terrill Park Dr. in Concord. Supplies are limited and orders may be reduced to accommodate the demand.
- NHED's **YES! scholarship program** is designed to help families and residents whose education was negatively impacted by the COVID-19 pandemic by awarding \$1,000 scholarships to New Hampshire students. The scholarships may be used for tutoring provided by [certified NH educators](#), as well as special education therapies and services provided by certified NH special education teachers or licensed therapists. - Waterford Upstart is an at-home, **early learning program** that helps children build reading skills before kindergarten so they can be confident in the classroom on day one.
