- Please review the **attached letter** regarding statewide assessment participation for 2022. USED has indicated that no waivers will apply to the 2021-2022 school year and 2022 assessments. Under the 95% district and school participation requirement, any students who opt out of the 2022 assessment below 95 % district and school participation requirement will be counted as zero scores.
- Following district meeting and voting season this March, please reach out to NHDOE if you recently expanded your school district's **kindergarten** program to full-day. Districts transitioning from a half-day to a full-day publically funded kindergarten program are eligible for State kindergarten start-up grants to assist in the implementation of the expanded program. - The 2022 **TangerKIDS Grants program** is accepting applications for the 2022-23 school year until June 30. This year, 40 percent of the grants will be awarded to serve underserved schools or facilitate accessibility and essential student needs.
- NHDOE has partnered with TeachUNITED to provide five rural schools in NH with customized professional development for their leadership teams and educators. **Congratulations to the five schools selected** for this unique program – Barnard Elementary School in North

Hampton, Stevens High School in Claremont, Northwood Elementary School in Northwood, Strong Foundations Charter School in Pembroke and Cornish Elementary School in Cornish. The focus of the program is to transform practices, engage youth and form professional learning communities within Rural Education Achievement Program school districts.
