- Please note that the **Universal Free Meal Waiver** for New Hampshire has expired and is no longer available for school district utilization. Districts must use the eligibility determinations for National School Breakfast and Lunch Programs (NSLP) that are outlined in the USDA's [Eligibility Manual](#). - Continuing with its efforts to close gaps and recover from missed learning, NHED has selected Tutor.com to provide 24/7 online **tutoring for students in grades 6-12** throughout the state. More information about this initiative may be found [here](#). School districts are being encouraged to [register](#) for Tutor.com's free access for their students.
- Per RSA189:64, every public, chartered public and nonpublic school is required to develop a site-specific **School Emergency Operations Plan (EOP)** that is based on and conforms to the Incident Command System and the National Incident Management System. Recently passed [HB1125](#) changed the due date from Sept. 1 to Oct. 15 each year. The School Readiness Program with the Division of Homeland Security and Emergency Management sent an email to schools with an updated school EOP template and checklist on Aug. 3. Schools are not required to transition to the new template, however the school EOP must address the new requirements outlined in the checklist.
