**Subject:** Director's Report

#### **LEGISLATIVE ACTIVITY**

Senate Bill 221, legislation that defines the jurisdiction of private postsecondary career schools and relative authority of the board of barbering, cosmetology, and esthetics (to approve certificate level programs), has passed the Senate and is expected to pass the House on May 8<sup>th</sup> and be forwarded to the Governor for signature. On February 10, 2014, the Commission approved the Administrative Rules for the Office of Career School Licensing (Hedc 300) that provide the specific standards and other procedures to be used in enforcing the revised statute.

House Bill 1377, legislation that would enable career schools to come before the Commission for approval to grant degrees, was voted inexpedient to legislate by the House. Dr. Gustafson had testified in opposition to this bill, citing the fact that the process for approval to grant degrees was already specified in statute and/or rules and at least one career school has obtained authority to offer a two-year degree (InterCoast College and Career School).

House Bill 624, legislation waiving the residency requirement for in-state tuition rates for veterans attending the University System of New Hampshire and the Community College System of New Hampshire, was approved by the Senate and then approved with an amendment by the House. The University System of New Hampshire stated this Bill would impact its revenue in FY 2015 and beyond, and the bill was referred back to the Senate Finance Committee. No Senate action has been taken on the amended bill as of this date, and we will track progress and keep the Commission informed.

# **REPORT OF OUT-OF-STATE MEETINGS**

I met with the New England Association of Schools and Colleges, Commission on Institutions of Higher Education (NEASC/CIHE) President Barbara Brittingham and Senior Vice President Pat O'Brien to discuss ways our entities could more efficiently coordinate distribution of NEASC related correspondence to the Commission. The policy of NEASC is to not share any communication with the respective institutions, even if the institutional chief executive officer authorizes such distributions. While they agreed to

review their policy in the case of the Commission, it was my sense we will need to rely on institutions to forward all communications and will not be able to receive these directly from the NEASC.

# STAFF DEVELOPMENT/OFFICE ISSUES/OTHER

We continue to recruit for the vacant Program Specialist III position (formerly held by Amy Slattery). This person will phase out the College Access Challenge Grant Program and assist the Director in support of all Division functions, including other federal grants, policy and planning, research and studies, financial aid, veterans state approvals, college and university activity, career school licensing, and support to the State Treasurer's Office for data analysis relating to the UNIQUE programs.

# **COLLEGE AND UNIVERSITY ACTIVITY**

The New Hampshire IHE Network: After conferring with the Commission, the New Hampshire Office of the Secretary of State approved the title of New Hampshire IHE Network for a separately incorporated 501(c)3 entity. The Secretary of State was concerned the organization's title may lead some to believe it was a public entity, and we decided that was not likely, especially since the organization has been in place for several years. The IHE Network has existed as a consortium of Teacher Preparation programs that advocate for initial and ongoing professional development for teachers. The 15 members of the New Hampshire IHE Network are listed in the attachment to this report, and include both public and private institutions.

#### **In-State:**

Required standard annual reports for institutions were reviewed and filed, and the following provides brief commentary on additional reports that will be due or special circumstances:

American College of History & Legal Studies notified the Commission it was closing at the end of this semester. Access to transcripts for all former and current students will be provided by the College's parent organization, the Massachusetts College of Law. The College is also working on a teach-out plan for the 13 current students

Daniel Webster College has a NEASC Progress Report due in the spring/summer of 2014

**Franklin Pierce University** has submitted its teach-out plan for the six academic programs closed in January (and noted in the prior Commission report).

**Mount Washington College** forwarded the required Compliance Report to the Commission on the Accreditation in Physical Therapy Education for the A.S. in Physical Therapist Assistant that was due by February 15, 2014.

**New England College** has approval to offer the following degrees without a terminal date: Associate, Bachelor, Master of Arts, Master of Education (in area which it already offers a Master of Arts), Master of Science, Master of Fine Arts in Creative Writing (Poetry), and Master of Business Administration. It also has approval to offer the Doctor of Education in Educational Leadership through December 31, 2015. The NEASC held a site visit in conjunction with the institution's ten-year comprehensive review on April 13-16, 2014, and I attended as the Commission observer.

**N.H. Institute of Art** had a substantive change review by the NEASC regarding its establishment of a Master of Arts in Art Education and Bachelor of Fine Arts in Creative Writing, merger with Sharon Arts Center, and implementation of a low residency MFA. The National Association of Schools of Art and Design (NASAD) also conducted a site visit in conjunction with the NEASC with a focus on the MFA programs in Visual Arts and Photography. The accreditors noted the need for a comprehensive strategic plan that addresses the merger and updated enrollment forecasts, both reported to be in progress by the Institute.

Southern New Hampshire University had a Commission on Collegiate Nursing Education (CCNE) site visit to review the new RN to BSN in Nursing and Master of Science in Nursing programs. The observer for the Commission was Dr. Sharon George, Dean of Nursing at Saint Anselm College. The evaluation was focused on accreditation standards relating to congruence with the institutional mission, adequacy of resources, curriculum and teaching, and student and faculty outcomes. Dr. George concluded SNHU is meeting the standards but there are some compliance issues that need to be addressed, and recommends the Commission defer approval until the final CCNE report/decision can be reviewed. Commission approval for the programs does not expire until December 31, 2016, or until CCNE acts, whichever comes first. A specific recommendation will be forthcoming to the Commission as soon as possible, and no later than December 31, 2016.

In addition, the Commission has received an inquiry from a private postsecondary school in New Hampshire regarding the process to obtain approval to award a postsecondary degree. And, as noted previously, Florence University of the Arts submitted an "intent to file" document to operate in New Hampshire, and has indicated it will soon submit an Evaluation Plan. Upon review of the plan the Director will appoint an evaluation team to travel to Italy and prepare a report for consideration by the Commission, possibly for the October meeting.

# **NEASC Activity:**

#### **COLLEGE ACCESS CHALLENGE GRANT (CACG)**
