## LEGISLATIVE ACTIVITY

Senate Bill 221, legislation that defines the jurisdiction of private postsecondary career schools and relative authority of the board of barbering, cosmetology, and esthetics (to approve certificate level programs), passed the Senate and House, and was signed into statute by Governor Hassan.

House Bill 624, legislation waiving the residency requirement for in-state tuition rates for veterans attending the University System of New Hampshire and the Community College System of New Hampshire, was approved by the Senate and approved with an amendment by the House. The revised language was approved by both bodies and signed into statute by Governor Hassan.

#### STAFF DEVELOPMENT/OFFICE ISSUES/OTHER

The recruitment process for filling the vacant Program Specialist III position (formerly held by Amy Slattery) continues, and may need to be filled internally by a current state employee due to "RIF" conditions in the State Employees' Association, Collective Bargaining Agreement. This person will phase out the College Access Challenge Grant Program and assist the Director in support of all Division functions, including other federal grants, policy and planning, research and studies, financial aid, veterans state approvals, college and university activity, career school licensing, and support to the State Treasurer's Office for data analysis relating to the UNIQUE programs.

## COLLEGE AND UNIVERSITY ACTIVITY

#### In-State:

We received notification from the U.S. Department of Education that **The College of Saint Mary Magdalen** satisfies the definition of an eligible institution under the Higher Education Act of 1965 and qualifies to participate in the federal student financial assistance program (Title IV, HEA programs).

**Daniel Webster College** submitted its required Annual Report on Finance and Enrollment to the NEASC. It also provided a letter from its parent company, ITT/ESI, confirming the company's financial commitment to cover operating deficits associated with online programming.

**Lebanon College** submitted its required Progress Report to the Joint Review Committee on Education and Radiologic Technology (JRCERT). At the April 25, 2014 meeting of the JRCERT, Lebanon College was granted accreditation for the Associate of Science in Radiography until October 2015.

**Southern New Hampshire University** and the **New Hampshire Institute of Art** announced they have entered into a Memorandum of Understanding regarding a possible merger.
