1. The LEA has provided continuity of services in addressing student academic needs: Description during SY20-21: Yes, the students were all in person learning last year and we worked to keep them on level and supported for the entirety of the year. For those families who needed to be remote, they were remote and fully supported with virtual video on a daily basis. Summer catch up was offered to all.

Description during SY21-22: Yes, we have been in person learning all year and will continue to be. Any students needing to be remote have been, and will continue to be fully supported with their schooling.

Our guidance counselor has reached out to all classroom teachers to provide support and to identify students who may be in need of extra SEL support. The food service director is ensuring that all students who want to eat our healthy breakfasts or lunches are provided with nutritious meals. The school nurse is helping to educate all staff, students, and parents on how to keep healthy and safe during the pandemic. All parents have access to our nurse or the school superintendent to help navigate the many facets of this pandemic.

3.	The LEA has provided continuity of services in addressing staff social, emotional, mental, and other health needs:				
	Description during SY20-21: Prior to the start of the 20-21 school year, the staff were invited to participate in a summer professional development session in order to prepare the school year which was full in-person learning. They were reminded of access to our health insurance carrier wellness programs and were encouraged to utilize those resources. Additionally all requests they had in regards to their social, emotional and mental health needs were addressed and taken care of.				
	Description during SY21-22: After a successful completion of the 20-21 school year, we felt adequately prepared to kick off the 21-22 year. However, all staff were reminded to take advantage of any supports available to them. The building principal meets with each teacher weekly to "touch base" with them and offer any additional support they may need to get through the pandemic as safely and healthy as possible.

### Appendix A. ARPA Statutory Excerpt

- "(i) Safe return to in-person instruction.—
- (1) IN GENERAL.—A local educational agency receiving funds under this section shall develop and make publicly available on the local educational agency's website, not later than 30 days after receiving the allocation of funds described in paragraph (d)(1), a plan for the safe return to in-person instruction and continuity of services.
- (2) COMMENT PERIOD.—Before making the plan described in paragraph (1) publicly available, the local educational agency shall seek public comment on the plan and take such comments into account in the development of the plan.
- (3) PREVIOUS PLANS.—If a local educational agency has developed a plan for the safe return to in-person instruction before the date of enactment of this Act that meets the requirements described in paragraphs (1) and (2), such plan shall be deemed to satisfy the requirements under this subsection."

#### Appendix B. Interim Final Requirements of ARP ESSER Excerpt

- "(3) LEA Plan for Safe Return to In-Person Instruction and Continuity of Services.
  - (a) An LEA must describe in its plan under section 2001(i)(1) of the ARP Act for the safe return to in-person instruction and continuity of services—
    - (i) how it will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policies, on each of the following safety recommendations established by the CDC:
      - (A) Universal and correct wearing of masks.
      - (B) Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding).
      - (C) Handwashing and respiratory etiquette.
      - (D) Cleaning and maintaining healthy facilities, including improving ventilation.
      - (E) Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments.
      - (F) Diagnostic and screening testing.
      - (G) Efforts to provide vaccinations to school communities.
      - (H) Appropriate accommodations for children with disabilities with respect to health and safety policies.
      - (I) Coordination with State and local health officials.
    - (ii) how it will ensure continuity of services, including but not limited to services to address students' academic needs and students' and staff social, emotional, mental health, and other needs, which may include student health and food services.
  - (b) (i) During the period of the ARP ESSER award established in section 2001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in person instruction and continuity of services.
    - (ii) In determining whether revisions are necessary, and in making anyrevisions, the LEA must seek public input and take such input into account.
    - (iii) If at the time the LEA revises its plan the CDC has updated its guidance on reopening schools, the revised plan must address the extent to which the LEA has adopted policies, and describe any such policies, for each of the updated safety recommendations.
  - (c) If an LEA developed a plan prior to enactment of the ARP Act that meets the statutory requirements of section 2001(i)(1) and (2) of the ARP Act but does not address all the requirements in paragraph (a), the LEA must, pursuant to paragraph (b), revise and post its plan no later than six months after receiving its ARP ESSER funds to meet the requirements in paragraph (a).
  - (d) An LEA's plan under section 2001(i)(1) of the ARP Act for the safe return to in-person instruction and continuity of services must be—
    - (i) In an understandable and uniform format;
    - (ii) To the extent practicable, written in a language that parents can understand or, if it is not practicable to provide written translations to a parent with limited English proficiency, be orally translated for such parent; and
    - (iii) Upon request by a parent who is an individual with a disability as defined by the ADA, provided in an alternative format accessible to that parent."
