(EHCY), Subtitle VII-B of the McKinney-Vento Homeless Assistance Act
LEA Sub grant awardees
Three (3) Year Funding Cycle 2016-2019

McKinney-Vento subgrants are awarded to Local Education Agencies (LEAs) on a competitive basis based on the need of the LEAs requesting assistance and the quality of their applications (Section 723(c) (I). Need is determined based on the identified needs of homeless children and youth and the ability of the LEA to meet such needs (Section 723(c) (2).

The number of homeless children and youth enrolled in early childhood education and other preschool programs, elementary schools and secondary schools, within the area served by the LEA; the extent to which the proposed use of funds will facilitate the identification, enrollment, retention, and educational success of homeless children and youths; the extent to which the application reflects coordination with other local and state agencies that serve homeless children and youths; the extent to which the applicant exhibits in the application and in current practice a commitment to education for all homeless children and youths are considered in the subgrant selection process (723(c)(2)(A)-(D)..
