

The New Hampshire Department of Education (NHED), Bureau of Special Education, offers guidance to Districts on IEP Amendments. This feature enables Districts to easily identify IEP Amendments in the New Hampshire Special Education Information System (NHSEIS). The dates of the current IEP as well as the original meeting date are listed on the IEP Cover Page. The date of the amendment should be the date the team proposes that the amendment will begin. The service date should reflect the date of the service increase, decrease, addition or deletion, and team should keep in mind that parents do have the 14 days to decide. An IEP amendment cannot be used to extend the end date of the IEP. In the student IEP Process, IEP Cover Page section, if the reason for the meeting IEP Amendment is checked, the IEP Amend Date box appears and must be completed. The Meeting date, IEP begin, and end dates will then be greyed out, locked, and unable to be changed.



As you can view, the date text boxes are unable to be changed.
