Training Descriptions:

SPED Aid, Court Order and Episode of Treatment Process: This training is for special education directors and special education support. Topics of discussion include how and what can be entered for Special Education Aid, the process for submitting costs for Court Ordered Placements and the most recent updates on entering and applying costs for Episodes of Treatment. IDEA Grant: Expectations for Activity Narratives: This training will provide detailed guidance on the key components and expectations for activity narratives, ensuring that submissions are clear, complete, and compliant with grant requirements. Participants will acquire a thorough understanding of the necessary elements to include in their narratives, thereby minimizing the potential for delays or returns for revisions. It is strongly advised that each LEA sends a representative to attend one of the sessions. Specially Designed Instruction I: Participants will learn what specially designed instruction is as defined by IDEA and how it applies to students with disabilities. They will gain a practical understanding of specially designed instruction, and the means in which it can be delivered as a service to special education students. Additionally, participants will learn how it is merged into the IEP using the special education process in a sequential and cyclical manner beginning with using evaluation data to describe unique student needs based upon present levels of academic and function performance, then identifying specific areas of specially designed instruction incorporated into special education services combined with annual measurable goals and progress monitoring. Indicator 13: Secondary Transition Compliance Monitoring: Secondary Transition planning is monitored through Individualized Education Program reviews (students aged 16 and older) for every school district every year. In this training, attendees will learn about the compliance requirements, (as outlined on the Indicator 13 Compliance Checklist), and how to use the Paperclip feature in NHSEIS to attach required evidence to a selected student's IEP. An overview of the monitoring process and how an LEA can best prepare for the initial monitoring review will also be addressed. Measurable Annual Goals: Participants will learn how to use the student information/evaluation data to write Present Levels of Performance of Academic Achievement and Functional Performance (PLOAFP –IEP Page 2). They will learn to use the pertinent student evaluation data combined with other current observation and assessment data to write present levels for each annual goal. They will learn what components need to be included in the writing of age –appropriate measurable annual goals and objectives based on each annual goal present level information; and how to write measurable annual IEP goals and objectives to help build the student skills so they can access, participate, and make progress in the general curriculum. Written Prior Notice: This professional development for Written Prior Notice (WPN) was created with stakeholder input in response to district requests for the Bureau to provide guidance regarding the use of and the content of WPNs. Indicator 8: Parent Involvement: This training will be for administrators responsible for developing systems for engaging their district's parents and families whose children have an IEP. By the end of this training, you will: understand the mechanism of the Parent Involvement Survey and how NHED uses its results, understand the timeline and process behind all steps of the survey [dissemination, launch, collection, and analysis], and walk away with tangible resources for you to use in various steps of the survey, including ideas on how to improve response rate. Assistive Technology Requirements: Each time an IEP Team develops, reviews, or revises a child's IEP, the IEP Team must consider whether the child requires AT devices and services. This training is designed to increase understanding of the Individuals with Disabilities Education Act (IDEA) assistive technology (AT) requirements. dispel common misconceptions regarding AT and provide examples of the use of AT devices and services for children with disabilities under IDEA Part C and Part B. The training is indented for a wide range of individuals, including parents, early intervention service providers, special educators, general educators, related services personnel, school and district administrators, technology specialists and directors, and employees of State lead agencies. Equitable Services Training: IDEA Equitable Services is a federal requirement that requires LEAs to spend a proportionate share of their IDEA funds to provide equitable services to children with disabilities whose parents have placed them in a nonprofit private school in the LEA's geographic area. IDEA also requires LEAs engage in timely and meaningful ongoing consultation to determine which parentally placed children with disabilities will be designated to receive special education and related services. This training covers the requirements of IDEA Equitable Services as it applies to New Hampshire covering both programmatic and fiscal components. Desired Results Developmental Profile (DRDP): Systems Training: This training is to learn how to use the DRDP online data system. A district account must be set up prior to this training. This system is the new system that is being utilized to collect Preschool Outcome Measures (POMS) data for Indicator 7 reporting purposes. During this training you will learn how to add users, set up classrooms, add students and input documentation and data for the students. You will also be taught how to run reports and what the reports can be used for in your classroom. NHSEIS Training for Administrators & Office Professionals: Participants will learn how to administer the use and maintenance of their NHSEIS site. Indicator 11: Child Find: Pursuant to federal requirements, each year, the Bureau of Special Education Support (Bureau) is required to report on IDEA Part B Indicator 11: the percent of children who were evaluated within 60 days of receiving parental consent for initial evaluation or, if the State established a timeframe within which the evaluation must be conducted, within that timeframe. Data for this indicator is derived from the information entered into the New Hampshire Special Education Information System (NHSEIS) by school district personnel and a subsequent desk audit. This training will provide an overview of the review process. Indicator 12: Early Childhood Transition: Pursuant to federal requirements, each year, the Bureau of Special Education Support (Bureau) is required to report on IDEA Part B Indicator 12: the timeliness of transitions from Family Centered Early Supports and Services (FCESS) to preschool special education. In accordance with 34 CFR 300.101(a), FAPE must be made available to all children with disabilities beginning on their 3rd birthday. This provision specifically requires that an IEP is in **EFFECT** for the child on the date of their 3rd birthday. Data for this indicator is derived from the information entered into the New Hampshire Special Education Information System (NHSEIS) by school district personnel. This training will provide an overview of the review process.
