***New Hampshire Rocks:***  
**Modern Band in the Granite State**  
**July 2020**

The New Hampshire Department of Education has secured funding to provide modern band instruments to no less than 12 schools and online training for music teachers from multiple school districts (up to 40 teachers).

**When:** The competitive grant process runs from July 13 – August 7, 2020. Notification will go out to selected schools by August 14. Online training for music teachers begins the week of August 17, exact dates TBD.
