Desired Results Developmental Profile (DRDP): This training will provide guidance on implementing the DRDP in your program. You will learn about the measurement tool and how to assess students. This is a new tool being supported by the state for collecting Preschool Outcomes Measures (POMs) for Indicator 7; Preschool Outcomes reporting.

* DRDP is a 2-part training. If your district is requiring DRDP training, you <u>must</u> attend both sessions to fulfill appropriate reporting requirements. When registering please state which 2 sessions you will be attending.
