Purpose

The purpose of this document is to provide all stakeholders with information regarding the available New Hampshire Department of Education (NHED), Office of ESEA Programs, Title I, Part A Allocation Transfer Among Local Educational Agencies (LEAs) process and subsequent request form.

Guidance

Per <u>ESEA Section 1126(b) allocations among local educational agencies (LEAs)</u>, may be transferred among LEAs that receive Title I, Part A funds. The NHED may allocate the amounts of Title I, Part A grants under sections 1124, 1124A, 1125, and 1125A among the affected LEAs—

- if two or more LEAs serve, in whole or in part, the same geographical area;
- if a LEA provides free public education for children who reside in the school district of another LEA; or
- to reflect the merger, creation, or change of boundaries of one or more LEAs.

LEA(s) should have an updated and approved internal policy on transferring Federal funds from one LEA to another, along with a formal agreement between both parties. The agreement should outline how the Federal funds will be maintained, and requirements that will be met between the parties.

Per 2 CFR § 200.334 the request, form, supporting documentation, and NHED's response must be maintained for record retention purposes.

Request to Transfer Title I, Part A Allocation Among LEAs



This form shall be used in the event an LEA(s) wishes to make a request to NHED to transfer their Title I, Part A allocation with another LEA for one of the approved reasons. This written request shall demonstrate due diligence and justification to meet full Title I, Part A requirements. The submission of this form does not guarantee approval. Please submit the fully executed document with the updated and approved internal policy on transferring Federal funds, as well as the signed agreement by both parties. If approval is granted, at no point during the school year should the LEA information change and Title I, Part A funds transferred back.
